## **VIRTUAL HEARING TIPS:**

- Prior to the hearing, please access the Zoom link above and download any needed software. This may take a few minutes, so it is best to download software in advance of the hearing. When logging-on to the hearing, please indicate your organization name in parentheses after your last name, if you represent one.
- All lines will be muted upon entry and stay muted throughout the hearing and video feeds will not be permitted.
- If you need assistance, please use the chat function to send a note to the meeting host. For call-in only users, press \*9 to raise your hand.
- If you need assistance accessing the hearing, please email FMSPTCEIS@icf.com.
- To hear audio when connecting through the Zoom link, please make sure the volume on your computer speakers is on and that you do not have any programs with audio features (e.g., Skype, Spotify, YouTube) open that may interfere with

the online hearing audio.

- A presentation video will be played during the virtual hearing, so please ensure your audio is working. As the video is playing you can use the Zoom Q&A feature to type in any clarifying questions you may have for the informal Question & Answer session.
  - After the presentation, there will be an informal Question & Answer session, which will allow you to ask any clarifying questions to the DAF personnel based on the video presentation. While this is your opportunity to receive additional information on the content provided in the presentation, questions are not considered official public comments that will be factored into the development of the Final SEIS.
- Individual internet connections and bandwidths may impact your viewing experience during the virtual hearing. It is best to close all other applications (i.e., Outlook) and limit streaming or downloads during the virtual hearing.

To ensure that the DAF has sufficient time to consider public input in the preparation of the Final SEIS, public comments should be submitted by **September 24, 2025**.
